Ragging is a serious concern in educational institutions, and this cell plays a crucial role in maintaining a harmonious and respectful academic environment. Anti-Ragging Cell should be one of the important part of Educational Institution's mechanism. As per the guidelines of UGC under the Act of 1956, which is modified as UGC regulations on curbing the menace of Ragging in higher Educational Institutions, 2009, establishment of Anti-Ragging Cell is very compulsory

- Definition of Ragging: Ragging, as defined by the Anti-Ragging Cell, refers to any act that causes physical or psychological harm, discomfort, or harassment to a student within or outside the educational institution. This
- includes but is not limited to bullying, teasing, abusive language, and any form of humiliation.

 Focus: The primary focus of the Anti-Ragging Cell is to eliminate any form of ragging within the college premises. It is committed to creating an atmosphere where students can pursue their studies without fear of harassment, intimidation, or any physical or psychological harm caused by ragging. As per the order of Supreme Court of India and subsequent Notification from University Grants Commission (UGC), ragging constitutes one or more of any intention by any student or group of students on:
 - Any act of Indiscipline, Teasing or Handling with Rudeness.
 - 2. Any act that Prevents, Disrupts the Regular Academic Activity.
 - Any activity which is likely to cause Annoyance, hardship, Psychological Harm or creates Fear or Apprehension.
 - Any Act of Financial Extortion or Forceful Expenditure.
 - 5. Any Act of Physical Abuse causing Assault, Harm or danger to Health.
 - 6. Any Act of abuse by spoken words, emails, SMS or public insult etc.
 - 7. Any Act of injury or infringement of the fundamental right to the human dignity
 - 8. Any Act of Wrongful Confinement, Kidnapping, molesting or committing unnatural offences, use of criminal forces, trespass or intimidation.
 - 9. Any unlawful assembly or conspiracy to ragging.
- Punishment to those found guilty: Any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments.
 - 1. Debarring from appearing in any sessional test / University Examination
 - Suspension from attending classes and academic privileges
 - 3. Withdrawing scholarships and other benefits
 - Suspension from the college
 Cancellation of the admission
 - 5. Cancellation of the admiss6. Withholding the results.
- Measures taken Up: The Anti-Ragging Cell takes several proactive and reactive measures to combat ragging. These measures include:
 - Awareness Campaigns: Organizing awareness programs and workshops to educate students about the consequences of ragging and the importance of maintaining a friendly and respectful campus.
 - Grievance Redressal: Providing a platform for students to report incidents of ragging anonymously, ensuring the confidentiality and safety of the Complainants.
 - Regular Monitoring: Conducting regular checks and vigilance within the college premises to identify and prevent potential ragging incidents.
 - Counseling: Providing counseling and support to both victims and those who engage in ragging to address the underlying issues.
- Objectives: Anti-Ragging Committee will be the supervisory and advisory committee in preserving a Culture of Ragging Free Environment in the college Campus. The main objectives of the Anti-Ragging Cell are:
 - To create a safe and secure environment for students.
 - To raise awareness about the harmful effects of ragging.
 - To discourage and prevent instances of ragging.
 - To provide support and counseling to those affected by ragging
- Activities:
 - The Anti-Ragging Cell engages in various activities to fulfill its objectives, including:
 - Organizing orientation programs to educate incoming students about the consequences of ragging.
 - Conducting surprise checks and inspections of hostels and campus areas.
 - Responding promptly to any complaints or reports of ragging.
 - Providing counseling and support to victims and perpetrators.
 - Collaborating with college authorities, faculty, and student representatives to maintain a ragging-free environment.
